2023 Scholarship Application

AHEPA Chapter 410 Scholarship Rules & Regulations

Eligibility Requirements for Applicants:

- 1. The applicant must be a member in good standing of the Daytona Beach AHEPA family or the child of a member in good standing of the Daytona Beach AHEPA family, or,
- 2. The applicant must be a fulltime resident of Volusia County, Florida and be a currently paid member of an Eastern Orthodox Church. If the applicant is less than 21 years of age, then the parent(s) or Guardian(s) must meet the residency and church membership requirement. The applicant must provide a letter from the Parish Priest indicating that the applicant (if over 21) or the family (if under 21) is a member in good standing.
- 3. The above requirements can be superseded in a situation of extenuating circumstances at the discretion of the Scholarship Committee.
- 4. The applicant must be a high school senior scheduled for Spring graduation and must show proof upon request that he or she has been accepted into an accredited College or University for the Summer or Fall semester immediately following their application, or a fully matriculated college student for the fall semester immediately preceding their application and the current semester at the time the application is made, with the intent to continue full-time enrollment in the Summer or Fall semesters immediately following their application. If a college student and enrolled in less than 12 credit hours, the applicant must provide documentation from the college verifying enrolled hours meet full-time student status.
- 5. The AHEPA family applicant is limited to receiving a maximum of four (4) AHEPA 410 scholarships during the course of their studies. Non AHEPA family applicants will be limited to one scholarship. If the AHEPA family applicant has already received four (4) awards from the chapter they will be considered ineligible.
- 6. A Non AHEPA family applicant is limited to receiving a MAXIMUM of 1 AHEPA 410 scholarship.
- 7. Letters of admission to accredited community colleges, colleges, or universities shall be provided within 10 days of request by the Scholarship Committee.
- 8. There is no minimum GPA for applicants. High school applicants with a 3.5 GPA and some AP classes are more competitive. Competitive College students should have a 3.0 GPA. College applicants who have taken more credit hours and more difficult classes will enhance their application.

Application Deadlines:

- 1. All completed scholarship applications must be postmarked NO LATER than April 28, 2023, for delivery to the Scholarship Committee chairman by <u>certified mail</u>. The application MUST include OFFICIAL ACADEMIC TRANSCRIPTS also postmarked by the April 28th deadline. If the ENTIRE application is not postmarked by April 28th the application WILL be rejected. The applicant is free to apply the following year.
- 2. An OFFICIAL TRANSCRIPT must be sent from the school the student is or was attending to the Scholarship Committee chairman. It is the responsibility of the student to ensure that the Scholarship Committee receives this official transcript NO LATER than April 28, 2023. High school transcripts must include all semesters for grades 9-12. College transcripts must be for all completed semesters (a minimum of 1).
- 3. A letter from the Parish Priest indicating membership good standing must be included.
- 4. Failure to comply with the above dates will disqualify the student of any award.

Selection Method:

- The Annual AHEPA Chapter 410 Scholarship Award Program will consist of a minimum of two (2) \$1,000 scholarships to applicants from a local Eastern Orthodox Church or AHEPA Chapter 410 Family.
- 2. Additional scholarships may be awarded, at the discretion of Scholarship Committee. These scholarships will be awarded based mainly upon the following criteria:

GPA:	40%
Difficulty of Curriculum	35%
Extracurricular Activities	15%
Economic Need	10%

- 3. All applicants shall be required to complete the attached scholarship application for submission to the Scholarship Committee by the indicted deadline.
- 4. The scholarship awards will be distributed on the basis of a deserving gift with no financial obligation on the part of the recipient.
- 5. The committee will officially communicate the approval or rejection of a scholarship applicant in writing to the applicant. Unless an award recipient is currently attending classes during a school semester, the committee expects the recipient to be present at the annual Awards Luncheon and church services the day of the luncheon.
